In 2019 health care providers, radiologists, breast surgeons, and advocates began working together to implement consistent recommendations and strategies to improve our region's breast cancer screening rates, decrease late-stage breast cancer diagnosis, and improve time from diagnosis to treatment.

It is estimated that 2,490 new cases of breast cancer will be diagnosed in Nevada in 2021 and 400 lives will be lost to this disease. Nevada's mammography rate remains below the national average of 71.8%, currently sitting at 66.4%. In addition to other factors, the numerous and significantly different screening mammography guidelines have continued to produce conflicting recommendations from physicians and created uncertainty for women.

In October 2019, our region adopted the most recent evidence-based recommendations from American Society of Breast Surgeons (ASBrS) released in May 2019.

ASBrS Breast Cancer Screening Recommendations:

1. Women age >25 should undergo formal risk assessment for breast cancer
2. Women with an average risk of breast cancer should initiate yearly screening mammography at age 40
3. Women with a higher-than-average risk of breast cancer should undergo yearly screening mammography and be offered yearly supplemental imaging; this screening should be initiated at a risk-based age
4. Screening mammography should cease when life expectancy is <10 years
