## MEDICARE DIABETES PREVENTION PROGRAM SUPPLIERS

**LEAP (Learn. Explore. Activate. Problem-solve.) Learning Labs** are topic-specific group-based learning opportunities offered through a collaboration between the Centers for Disease Control and Prevention (CDC) and the National Association of Chronic Disease Directors (NACDD) to help State Health Departments actively pursue new or enhanced approaches for scaling and sustaining the National Diabetes Prevention Program. LEAP Learning Lab participants learn and contribute to identifying promising practices, effective tools, and resources.



### In this Learning Lab, You Will...

- Gain knowledge about the purpose, structure, and benefits of developing and sustaining Medicare Diabetes Prevention Program (MDPP) suppliers.
- Receive support from MDPP experts and peer networks.
- Build new partnerships to streamline MDPP processes and reimbursement structures.
- Plan the development of an MDPP supplier in your state or region.

### Afterwards, You Will Confidently...

- Engage CDC-recognized organizations with preliminary or full recognition status within your state, city, or county to become MDPP suppliers.
- Identify resources for MDPP suppliers.
- Understand new Centers for Medicare & Medicaid Services policies intended to boost supplier enrollment.
- Help potential MDPP suppliers develop an implementation plan and prepare to successfully bill for MDPP services.

## What to Expect

- Ten 90-minute Zoom meetings, including:
  - A two-part MDPP billing workshop
  - Two office hour sessions with state case studies and technical assistance
  - A didactic learning environment that includes peer-to-peer sharing, games, panels of existing MDPP suppliers, and peer-led discussions
- Recruit and partner with an interested CDC-recognized organization in becoming an MDPP supplier
