Purpose:

The Umbrella Hub Arrangement (UHA) Summit is a dissemination of the lessons learned from Umbrella Hub Demonstration Organizations (UHOs), Learn. Explore. Activate. Problem Solve. (LEAP) participants, Medicaid Beneficiary Enrollment Project (MBEP) participants, Medicare Diabetes Prevention Program (MDPP) Enrollment Project participants, state health departments, national organizations, and other partners. This 1.5-day summit will convene emerging UHAs for peer-to-peer discussion and sharing of successful strategies to operationalize a UHA.

Objectives:
