# Michigan





- SPINE Breastfeeding Project Summary: A breastfeeding
  project building upon the success of the QI-TRACS project.
  Utilizing black-led and owned community partnership to ensure
  discharge support and follow-up through a community referral
  form from the hospital, in two Detroit Communities.
- One big win: Embedding a Community Organizer in the hospital system.
- One challenge: Creating system change by getting another hospital system to adapt a process that has been shown to work, with much early success.



- SPINE Project Summary: MDHHS is partnering with the Michigan Local Food Council Network to develop local food councils' ability to engage in policy and advocacy at the state and local level.
- One big win: The councils have all chose their policy agendas and are working to figure out how to enact them.
- One challenge: All the councils were at different starting points, with different resources and capacity which means they have very different technical assistant needs.

## Oklahoma



### **Oklahoma SPINE Project**

Working with Federally Qualified Health Centers to establish food insecurity and/or social determinants of health screenings, establish an on-site food pantry, and develop referral system for ongoing community resources.

#### **Sub-contracting with 3 organizations**

- Oklahoma Primary Care Association
- Regional Food Bank of Oklahoma
- Food Bank of Eastern Oklahoma

The **biggest challenge** was contracting delays.

The **biggest win** is that despite contract delays, our partners were invested in this work and had identified intervention locations already.

**Another win** is that we have interest from other clinics to expand beyond the two intervention locations. Both food banks believe they have the resources available to proceed with other clinics.















### **Oklahoma SPINE Breastfeeding Project**

Increase funding for the Baby Friendly Hospital initiative to include additional funding for 11 hospital redesignation fees and increase evidence-based breastfeeding education to health care staff in rural and tribal hospitals.

#### **Sub-contracting with 1 organization**

- University of Oklahoma Health Science Center
  - Oklahoma Breastfeeding Resource Center

The **biggest challenge** has been contracting. Though we already had a contract with the organization, revising the contract to include additional funding has been time consuming.

The **biggest win** is that despite contract delays, our partner is already doing this work and already has a strategic plan for how to use the additional funding. They are ready to go as soon as they receive a revised contract.
