[Health Information Technology \(HIT\) Assessment Survey](#)

A Qualtrics survey for partner clinics to complete. It provides a picture of what knowledge, skill, and capacity they have with their EHR. We use this survey to create an initial workflow showing engagement with their EHR (see workflow sample below) and potential “hot spots.” These tools are used to facilitate the discussion at the HIT Assessment meeting.

We create this tool Lucidchart after the HIT Assessment Survey is completed and key informant interviews conducted. The workflow maps the understanding of engagement by specific staff with the EHR. Clinic staff review and correct any inaccuracies and use it to identify challenges.

The Jackson Laboratory, American Cancer Society, and National Colorectal Cancer Roundtable developed a toolkit for primary care providers to help them implement a structured family history collection system to identify and manage individuals at increased or high risk of colorectal cancer (CRC), and to facilitate timely diagnostic evaluation of patients with signs or symptoms of early onset CRC.

One method of sharing screening rate data is through a one-page data report shared with our enrolled clinics through our medical directors and clinic liaisons. The report shows the overall screening rate, as well as screening rates for race, sex, and insurance status. The report shows their overall screening rate compared to the state average, and shows the completed rate for FIT kits, colonoscopies, and follow-up colonoscopies.
