INTRODUCTION

The National Diabetes Prevention Program (National DPP) and diabetes self-management education and support (DSMES) services effectively prevent and manage diabetes, respectively. State Health Departments (SHD) have the task with increasing participation in these programs by providing technical assistance (TA) to program providers.

The National Association of Chronic Disease Directors (NACDD), in partnership with the Centers for Disease Control and Prevention (CDC) and other leaders in diabetes, developed and launched the State Specialists Program for SHD staff in 2020 to support TA efforts.

The State Specialists Program is for SHD diabetes staff working to expand access to and participation in diabetes prevention and management programs. This workforce training and development program combines extensive training and peer networking, resulting in a workforce with the skills and competencies to provide TA to support expanding access to and participation in diabetes programs, particularly in communities experiencing higher rates of prediabetes and diabetes.

Toolkit Purpose

This toolkit will help you and other State Specialists create awareness of how you can support diabetes prevention and management programs in their efforts to expand access and availability to the National DPP and DSMES services in your state. The Toolkit provides you with tools and resources to increase awareness of your efforts to ensure programs can continue to provide services to help decrease type 2 diabetes risk and improve diabetes-related outcomes, with an emphasis among communities disproportionately affected by diabetes.

This toolkit can help you:

- Increase awareness among programs of the benefits of consulting with State Specialists, including types of TA you can provide.
- Expand your reach to support organizations seeking to develop, expand, and sustain diabetes programming in your state.
- Build and sustain relationships with new and existing delivery organizations and partners.

This toolkit provides tools and resources developed by other State Specialists that you can use to engage program and service providers in your state including:

- Outreach message templates for new and existing program providers.
- State Specialist Fact Sheet template.

Pick and choose the tools and resources that align with your outreach efforts and modify them, as needed. While some resources are specific to National DPP or DSMES, you can adapt them to meet your needs.

WHY PROMOTE STATE SPECIALIST SERVICES?

The State Specialists Program has provided you with the knowledge and skills to deliver expert support to National DPP program providers and DSMES service providers who have many requirements to ensure the proper delivery of these programs and services.

Promoting your services is critical to their success as you can:

- Provide guidance on building quality programming to support participants.
- Identify ways to increase access and participation among priority populations.
- Discuss best practices for recruitment, engagement, retention, and program sustainability.
- Advise on current program and service delivery requirements and methods for meeting those requirements.



THE ESSENTIALS

Consider these essentials as you prepare:

- 1. Messaging and Communication**

Use consistent messaging and communication. Nurture new connections and partnerships through follow-up and relationship-building. Build trust with diabetes program and service providers by providing timely and accurate responses to their queries.
- 2. Tools & Resources**

Gather your existing tools and resources to aid you in developing your outreach messages. Consider a variety of methods to increase awareness of State Specialist services including information on your website, fact sheets, e-mail outreach, newsletters, and social media.
- 3. Self-Promotion**

Create awareness of your role as a State Specialist when you attend community events, network meetings, Lifestyle Coach trainings, and other professional encounters. Promote your services broadly to build new partnerships and ensure access for diabetes delivery organizations who need additional support.



OVERVIEW OF OUTREACH TOOLS

Determine what tools and resources you will need for your outreach efforts. Use existing tools and resources developed by other State Specialists, including:

- An email signature line.
- Sample email messages for interested, new, or existing National DPP program delivery providers.
- Sample email messages for interested, new, or existing DSMES service delivery providers.

Strategize how you will can use these tools to reach out to individual organizations or in mass communications. Tailor the tools and resources to meet your needs and adjust based on the messages you will communicate to new and existing program delivery providers.

About The National Diabetes Prevention Program

The [National DPP](#) is a yearlong CDC-recognized lifestyle change program that supports and motivates individuals to eat healthy, increase physical activity, and cope with stress and challenges. Research has shown that completing the lifestyle change program reduced participants' chances of developing type 2 diabetes by 58% (71% for individuals ages 60 and older). CDC-recognized National DPP programs have trained Lifestyle Coaches who have the knowledge and skills to effectively deliver the program.

[Diabetes self-management education and support](#) (DSMES) services is a cost-effective tool that has been proven to help improve health behaviors and health outcomes for people with diabetes. People with diabetes who participate in DSMES services accredited by the Association of Diabetes Care and Education Specialists (ADCES) or recognized by the American Diabetes Association (ADA) improve their quality of life. These benefits may include A1c reduction, decreased healthcare costs, and improved self-efficacy.

- Most states have at least one trained State Specialist trained to provide tailored technical assistance and support to delivery organizations in their states.
- State Specialists are part of a network of State Specialists who receive continuous support and training to provide technical assistance and support to program delivery organizations.

What is a DSMES State Specialist and how can they support your work?

- DSMES State Specialists are State Diabetes Health Department staff who have undergone specialized training and have the skills and tools needed to expand access to and availability of high-quality DSMES.
- Many states have at least one trained DSMES State Specialist trained to provide tailored technical assistance and support to DSMES services in their states.
- DSMES State Specialists are part of a network of State Specialists who receive continuous support and training to provide specialized technical assistance and support to DSMES service delivery organizations, supplementing the support these organizations receive from the American Diabetes Association and the Association of Diabetes Care and Education Specialists.
