This year's event will focus on the three themes: **Connect, Engage, Innovate**.

Priority Topic Areas

Data Modernization and Artificial Intelligence

How chronic disease programs are applying advanced analytics, artificial intelligence, and modern data tools to enhance surveillance, streamline workflows, improve decision-making, and accelerate innovative solutions for chronic disease challenges.

Connect

- Building data-sharing partnerships across agencies, sectors, and community organizations
- Creating integrated data ecosystems that support collaborative chronic disease monitoring
- Strengthening cross-program alignment through shared dashboards and analytic tools

Engage

- Using data visualization to communicate insights to communities and stakeholders
- Co-designing data tools with end users to ensure accessibility and relevance
- Empowering local partners with actionable data for community-driven prevention strategies

Innovate

- Applying AI and machine learning to identify trends, predict risk, and inform interventions
- Automating routine data processes to free staff capacity for strategic work
- Using advanced analytics to evaluate program impact and guide real-time decision-making

Health Communication and Storytelling

Engage

- Leveraging digital platforms to foster two-way communication and sustained engagement

Innovate

- Applying human-centered design to craft compelling public health narratives
- Using multimedia storytelling (video, animation, interactive formats) to enhance message impact
- Integrating behavioral science insights into communication strategies for chronic disease

Partnerships

How chronic disease programs are cultivating cross-sector partnerships—with healthcare, community organizations, education, business, and government—to expand capacity, align resources, and drive collaborative approaches to chronic disease prevention.

Connect

- Building and sustaining multisector coalitions for chronic disease prevention
- Strengthening partnerships between public health and healthcare systems
- Leveraging regional networks to align chronic disease priorities and resources

Engage

- Co-developing community-led prevention initiatives with trusted local partners
- Engaging nontraditional partners (e.g., housing, transportation, employers) to address social drivers of health
- Using participatory approaches to ensure shared decision-making and accountability

Innovate

- Designing new partnership models that integrate technology, data, and community expertise
- Piloting cross-sector funding or resource-sharing strategies
- Using collaborative innovation labs to test and scale chronic disease solutions

Session Types

Abstracts will be considered for the following virtual session formats.

Workshop Sessions

- **Format:** 60–90 minutes
- **Focus:** Skill-building, collaboration, and shared problem-solving
 - Workshops emphasize active learning and peer exchange. Presenters serve as facilitators, guiding participants through hands-on activities, small-group discussions, or scenario-based exercises. Sessions should include practical tools and real-world applications.
- **Ideal for:** Co-creation, case-based learning, simulations, facilitated dialogue.

Lightning Talks

- **Format:** 10-15 minutes, rapid-fire, image-driven
- **Focus:** Big ideas, emerging innovations, concise storytelling

- Presenters deliver a focused, visually compelling narrative that sparks curiosity and inspires new thinking.
- **Ideal for:** Emerging ideas, pilot projects, community stories, early innovations, lessons learned, or “aha moments.”

Digital Poster Presentations

- **Format:** Digital poster and live Q&A
- **Focus:** A concise, visually engaging way to share program highlights, evaluation findings, innovative approaches, or emerging ideas in chronic disease prevention and control.
 - Presenters create a digital poster (PDF or slide-based) that participants can view on demand, with a brief live or chat-based Q&A during the Academy.
- **Ideal for:** Program summaries, evaluation snapshots, pilot projects, data visualizations, community stories, early innovations, or work that benefits from a visual, concise format.

Spotlight Session

- **Eligibility:** This session type is open to State and Territorial Health Departments only.
- **Format:** 20–30 minutes, plus Q&A
- **Focus:** Promising practices, program models, evaluation findings from State and Territorial Health Departments
 - Presentations should tell a compelling story, highlight evidence-informed strategies, and offer actionable insights. Presenters are encouraged to incorporate interactive elements such as polls, chat prompts, or reflection questions.
- **Ideal for:** Program spotlights, evaluation results, partnership models, data-driven approaches.

Academy Learning Objectives

All selected presentations must include clear learning objectives that enable participants to:

- Establish meaningful partnerships and networks across multidisciplinary teams and sectors to strengthen collaborative approaches to chronic disease prevention and control.
- Develop strategies to meaningfully engage communities, stakeholders, and populations in prevention initiatives that promote health for everyone and drive sustainable behavior change.
- Identify emerging technologies, data solutions, and creative approaches to address chronic disease challenges and enhance public health program effectiveness.

Presenter Eligibility

Presenters can represent any organization that works to improve the health of the public such as, but not limited to, State and Territorial Health Departments, universities, local health departments, tribal organizations, non-profit organizations, clinics, etc. The Spotlight Session type is exclusively reserved for abstracts from State and Territorial Health Departments.

Submission Requirements and Details

Participants may [submit abstracts](#) for more than one session type. Selected abstracts will meet virtual academy learning objectives within the priority topic areas. An abstract may be selected for a different focus area than it was submitted for. **Presenters of selected abstracts are expected to attend all three days of the event.**

If your abstract is selected, **all presenters must register for the event and are responsible for the cost of their registration fee.** Note, chronic disease staff at State and Territorial Health Departments can register for the Academy as a 'General Member.'

NACDD will notify all applicants about the status of their abstract in July 2026.

The Abstract Submission Form will ask for information about the following items. You can review all questions at the end of this document. We suggest drafting your responses in a separate word document and when you are ready, submit your application through our [Abstract Submission Form](#).

- **Primary Contact:** This should be the primary presenter of the abstract. NACDD will communicate with this person about abstract status and event details.
- **Team Participation:** Indicate who will participate in the presentation with you, if selected.
- **Abstract Details:** What your presentation is about and how it reflects the priority areas, theme, and learning objectives for the 2026 Academy.
- **Program and Innovation Details:** What the status of your work is (planning, pilot, lessons learned, etc.) and what's included in its evidence base.
- **Session Format and Technical Details:** Indicate your preferred presentation format. Final format will be determined by the planning committee. Confirm your comfort using the virtual presentation platform (Zoom) with interactive features.
- **Agreements and Acknowledgements:** Recognition that by submitting an abstract, your team is committing to presenter and accessibility statements.
